Enrollment & Deposits: Any customer wishing to participate in this program must complete an enrollment form and place a non-refundable deposit of \$300 per couple. This deposit will be applied to your trip account once your trip is completed.

Trip Costs: Double Occupancy: 41,100 points per couple

Single occupancy: 29,100 points per person

Third person, as adult: 13,900 points per person (13 years and older)
Third person, as child: 11,000 points per person (12 years and younger)

Additional Trips: There is no limit to the number of trips you may earn.

Buy-in Option: Should your trip fund not fully cover the cost of your trip, you may "Buy-in" for the unearned portion as long as you are at least 75% qualified at the end of the qualification period.

Qualification Period: December 1, 2023 – May 31, 2025 (18-month qualification period.)

Travel Dates: Saturday, September 6 - Sunday, September 14, 2025

Entry Requirements: U.S. Citizens on "closed-loop" cruises will be able to travel with proof of citizenship, such as an original or certified copy of his or her birth certificate (issued by the Vital Records Department in the state where he or she was born) and, if 16 or older, a government issued photo ID. Although not required, a valid U.S. passport is certainly recommended. Non-U.S. citizens should contact their local consulate for travel requirements.

Cancellations: Any customer wishing to drop out of this program may do so. Any cost incurred by Kaough Distributing Company as a result of cancellation will be deducted from your point fund or invoiced to you if your point fund does not cover. Your balance will be credited to your account, but Kaough Distributing Company bonus points contributed are not refundable and may not be used to cover any cancellation charges.
